#### LLANDUDNO SRA and LCA CHAIR Kiki Bond-Smith

As you may know, a Llandudno SRA member's meeting was held in the School hall on 6 April at which the proposed increased SRA levy was debated and approved. I realise that this has caused considerable unhappiness with some residents. Most of it was caused by a lack of awareness surrounding some of the regulatory aspects governing the SRA. The 'big' issues were the confusion as to the roles of the SRA vs LCA, the voting system, the eligibility to vote, the need for an increased security level based on actual crime in the area, the SRA board 'rushing' through this increase and its affordability. I will explain these in more detail below, hopefully this will clarify the issues and address the concerns.

SRA vs LCA: the LCA is the old Llandudno Civic Association, a ratepayer association with its own Constitution. Membership is automatic and eligibility to vote is conditional upon having paid the voluntary LCA annual contribution, set at R750 per annum. The LCA continues to be responsible for commenting to the City on Llandudno building regulatory matters, but has no 'jurisdiction' or enforcement capacity. It is also our formal communication channel with the City via the Ward Committee and will be used should there be any litigation with the City.

Because of the voluntary nature of contributions, the resulting lack of financial support and given the outcome of a survey done some years ago, where improved security was identified as one of the key needs in the Llandudno

community, it was decided to embark on the process to establish an SRA, or Special Rating Area. The voting returned that 66% of Llandudno property owners voted in favour of forming a SRA. The City approved this process and a Not for Profit (NPC) Company was formed in terms of the Companies Act. The Llandudno SRA was registered with effect from 1 July 2015 with a Memorandum of Incorporation (MOI) as stipulated and provided by the City. Registration was effected by the CIPC (the entity responsible for registering the SRA which is administered by the Department of trade and industry.

Thereafter, all owners of properties within the geographic area of Llandudno, can become members (the term used in this context for shareholders) of the SRA. Voting in favour of the establishment of the SRA did not automatically mean that a property owner became a member of the SRA and we have at all times since its establishment notified owners urging them to register as members of the SRA because membership is precondition for voting at any formal member's meeting. This matches the requirements of Company Law where only shareholders of a company can vote at its AGM or other shareholders' meetings.

To prevent future confusion between these two entities, the City has also requested that the SRA and LCA websites be separated, this is in the process of being done with our web administrators.

Eligibility to vote: In order to vote at any members meeting of the SRA, owners must apply to become members of the SRA. This is available free of charge to any property owner and we will update the members' list and publish it on the website so owners can verify for themselves whether or not they are members. Membership is not automatically transferable and ceases if you sell your property. The new owner will have to apply to become a member. A condition of membership is that a member agrees to the objects of the Company as set out in the MOI. This is not a condition imposed by the SRA board to obfuscate issues, but is a requirement of the Companies Act, to which the Llandudno SRA is subject.

The voting system: Voting occurs by means of show of hands and one vote per property, even where there is more than one owner. If requested in a meeting by owners holding 10% or more of all the voting rights, or by 5 or more owners, then voting will (must) occur on a weighted basis, with one vote being afforded for each R5m of municipal valuation of property. Again this is not something the SRA board devised, but is a requirement of the City's SRA by law, read with the Companies act where a shareholder votes according to the number of shares owned. At the meeting of 6 April, the voting was conducted using both methods and resulted in a similar outcome with approximately 66% of owners voting in favour of adopting the resolution increasing the SRA budget as tabled at that meeting. It was explained at the meeting, that should we as a community wish to change the voting basis to one or the other method, then we need to change the MOI and this will require a special resolution i.e. 75% of members voting in favour of it. The need for the increased levy is based on actual crime occurrences in the area and is amplified under the security section in this newsletter.

Rushing things through: The necessity of holding the meeting in April was because of the timelines within the City for approval of the budget with effect from 1 July 2017. The timelines prescribed by the City and in terms of the Companies Act for the notice period to the meeting were adhered to.

Affordability: many residents who opposed the increased SRA levy appear to have been motivated by lack of affordability. It has been stressed that the increased SRA levy amounts to less than 10% of rates, and it is actually the rates themselves which are not affordable and not the SRA levy per se. Secondly whilst only approximately 15% of our rates are spent back into our area, the balance being spent to uplift other areas, 100% of the SRA levy gets 'ploughed back' into Llandudno. We are also in the process of liaising with the City to establish whether additional rates relief mechanisms can be found to assist residents who are struggling with affordability. Residents who qualify for rates relief, even on a pro-rata basis, are exempt from paying the SRA levy in its entirety. In the period leading up to the meeting of 6 April, we explored various other possible relief mechanisms, which were found not to be possible within the existing regulatory framework.

In summary, whilst everyone may not be happy with the outcome of the process, the fact remains that due process as prescribed by the relevant regulatory frameworks was followed. This was examined by the City which has confirmed that due process was followed. The resolution in terms of which the levy was increased, was supported by the majority of residents eligible to vote - in fact some two thirds. I would urge resident owners to register as members of the Llandudno SRA and to attend meetings in future to ensure they remain familiar with happenings in our neighbourhood

### LLANDUDNO SECURITY Llandudno Security Committee

The website has been updated with an "Information Sheet" that adds significant detail to the information below, (www.llandudno.org.za/security.html). As this is contentious issue; the SRA has solicited opposing viewpoints which also be posted on the website.

The SRA Improvement District levy increased significantly on 1 July after a series of public meetings & dialogues that resulted in a widely attended public vote for an amended security budget with other minor admin corrections. The meeting was called due to public insistence following a particularly bad series of home-invasions in Llandudno from October 16 to Aril 17; which occurred on-top of the same overall increasing trend in the Hout Bay area generally (see website). Unfortunately, enhancing the existing security contracted services was not viable, as the COCT warned the SRA that it can NOT negotiate on-behalf of residents with regard to their Home-Alarm contracts.

ADT-Fidelity Home Contracts provide Home Alarm Response contracts to those residents who wish to voluntarily subscribe to this service. The contract enables ADT to legally enter your property in an emergency and includes: monitoring & responding to home-alarms with a single dedicated patrol car & armed responder ("Hotel 4"), 24-hour unarmed guard at top-hut, night-time unarmed guard at Sandy Bay path, night-time unarmed dog patrol, and armed back-up from Hout Bay if necessary & available. ADT-Fidelity is not contractually obligated to respond to crimes/suspicious-activity that occur on roads or public spaces. This can only be done by SAPS or a specifically contracted dual-member TRT (Tactical-Response-Team).

A TRT is NOT allowed to respond to a home-alarm by entering your home...unless they have a direct contract with the home-owner to-do-so (and this is a level of private security that is normally much more expensive); conversely, they cannot viably patrol public-spaces without an agreement with the SRA. However, pending completion of the bidding/contracting process for such a TRT to cover public-spaces (see below); ADT-Fidelity has voluntarily offered, as a gesture of goodwill, to combine their night-time dog-patrol with a free temporary night-time TRT.

Cameras already exist throughout Llandudno but generally not on the perimeter. Most have been donated. The SRA provides the integration, up-keep, and monthly service fees for the system. Verifier is a contractor that provides 24-hour security camera monitoring services. DSCS (Digital Safeguard CCTV Solutions) is contracted to the SRA and tasked with maintenance.

Following the vote to increase the security budget, two sub-committees were formed: i) TRT (Tactical Response Teams), and ii) Technology for early detection and tracking. These sub-committees also included residents who voted against the levy increase; but volunteered to make it as effective as possible. It was generally agreed that:

- Effectiveness of the Tactical Response Team is largely dependent upon the effectiveness of the technology providing early criminal detection & locations; and vice versa.
- Coverage Fairness noting that all areas of Llandudno have been effected by crime; effort was made to ensure that both a very comprehensive (i.e. "Coast-to-Coast and Green-Belts") and an equitable-distribution of coverage was provided.
- Alternative plans were investigated and found not viable/sustainable (for example: fence, drones, street-lights, etc...)
- Tendering Process specified to enable passing of City audit process and public scrutiny.
- Testing of the System after commissioning...is to become the priority of the Llandudno Security Committee "LSEC".

TRT (Tactical Response Team) Upgrades are planned as follows:

- CCP & ADT-Fidelity is currently providing some temporary coverage; with staff given training by the LSEC on the existing security system.
- TRT contractor interviews have been conducted with all of the major service providers; with a mandate to provide: 1 Vehicle, 2-specially trained/experienced staff (possibly with 1 during day & 3 at night), 1-certified tracking-dog, & up to date security equipment, in Llandudno 24-hours per day, with the explicit requirement to engage criminals on public roads and land prior to getting to our perimeter. Depending on

the tendering process, response, and availability...the hope is that we will have the TRT in place by 1 September.

Technical Upgrades are planned as follows:

- Existing System has been: tested & repaired; currently with more work in-progress.
- New Equipment Selection to be determined by the LSEC Technical Subcommittee through testing on-site in Llandudno.
- Security Integrator Interviews have been conducted with all of the major service providers; with mandate to install upgrades while concurrently integrating and maintaining the existing equipment.
- Sensors Numerous confidential alternative/complimentary technologies were experimented for heavily over-grown areas.
- Camera extensive testing was done of Long-Range Thermal PTZ (Pan-Tilt-Zoom) cameras; confirming that the concept of Long-Range Thermal detection is viable and within budget.
- Locations & Areas Covered via both: i) adding long-range thermal cameras for early-warning & pursuit surveillance for the area around the outside of the entire perimeter, and ii) increased: LPR facilities, tracked armed patrols, and confidential technologies for the internal/green-belt areas. The exact details will have to be kept confidential; but residents are encouraged to join the LNW to receive a one-on-one briefing by contacting the LSEC. Depending on the tendering process, response, and availability...the hope is that we will have the new equipment/technology in place by 1 October.

Unfortunately it takes the personal touch out of a conversation that a telephone call offers and the shorter text can lead to lead to miscommunication but nonetheless it is the way of the future and provides a certain speed and efficiency.

As a result we have set up various social media platforms in Llandudno to communicate with residents at different levels. A short summary of what's is available to residents:-

- Llandudno Organised is a closed Facebook group for residents that provides a platform " to chat " about issues in the neighbourhood from a burst pipe, lost dog / cat , post a photo or other community events .It is not a commercial advertising platform nor a security portal. Membership to this group is restricted to Llandudno residents only for ease of management.
- 2 Security WhatsApp groups were established to replace the previous WhatsApp Street security groups. This was done at the request of residents that the groups be more inclusive. These Security WhatsApp groups are strictly for crime alerts and are not chat groups. They are monitored by security executives in Hout Bay who manage many other groups. It was at their request that this remains purely an alert platform and no chats are allowed
- The WhatsApp group "We Love Llandudno" was set up to fill the gap with those more inclined to chatting and is a busy platform.

This season our lifeguards logged over 5000 volunteer hours on the beach and maintained our record of zero drownings on our watch. We have already started a new course to qualify 46 members to fully fledged lifeguards for the new season with Chris our instructor.

Congratulations to our competitors and managers who yet again attained fantastic results at the SA Champs with our Seniors achieving a 3rd overall and our Nippers being very well placed prior to the competition being cancelled due to very rough conditions. Our fund raising team have again been incredibly busy raising funds to ensure we are able to offer the service that we do with equipment that is well maintained. We are also very grateful to all those that support the club throughout the year with donations and sponsorship such as Cape Waterfront Estates, Red Paddle and The River Club.

We had a great "End of Season Bash" and prize giving at Suikerbossie where we were happy to announce that we had eight Nippers and eight Juniors & Seniors chosen to represent WP Lifesaving at the Inter-provincial Championships. In addition one of our Masters Kit Beaton has been chosen to represent South Africa at the World Champs in Denmark this year - we wish him well with this endeavor.

Steven Sparks and Natan Brittz receive Bravery Awards at the recent Lifesaving Western Cape AGM.

Steven Sparks and Natan Brittz were on professional lifeguard duty at Llandudno beach, on Wednesday, 7th December, 2016, at about 2pm, when the squad was alerted to a person floating in the turbulent water near the notorious "Gat", the most dangerous place in the bay, where massive waves break onto jagged rocks. Natan immediately donned his wetsuit and set off with fins and a torpedo buoy into the fearful conditions. Huge surf was closing out across the bay and visibility was poor, as the morning fog was still lifting. Natan swam harder and dived deeper than ever before and was soon behind the backline, where surfers pointed him towards the edge of the "Gat", a treacherous area with powerful rip currents. He spotted the victim in the impact zone, close to the rocks, and timed his approach carefully as the massive waves thundered past. He secured the victim, observing that he appeared to be dead. However, not wanting to take any chances, Natan placed the patient on his shoulder and used his torpedo buoy as a floatation device to keep the patients head out of the water. Giant sets kept rolling in and he battled to keep the patient secured. Another wave hit them and washed them to less than five meters from the rocks. At this point he saw the third wave of the set approaching and knew if he continued holding on, he would be washed into the rocks. He let go of the victim and swam and duckdived under the biggest wave of the set. After this third and final set wave he quickly found the victim again, put him into the rescue position and swam him out beyond the waves. Once safely beyond the impact zone, he started swimming the victim across the bay, when two surfers arrived to lend a hand. At this point fellow squad member, Steven, who had initially tried to get out on a rescue board, had also arrived after swimming out, and assisted in getting the patient across the bay and through the backline and shore-break, back to the beach. Paramedics declared the victim dead at the scene.

A letter of Commendation was awarded to Steven and a Certificate of Commendation to Natan for unhesitatingly going in search of the patient in the treacherous conditions, and for persisting in recovering the lifeless person in almost an hour of extreme endeavor. Natan and Steven are congratulated on their brave rescue effort, which is in keeping with the high ideals of rescue and service which Lifesaving South Africa endeavours to promote and practice.
