
#### **THANKS TO HUCK**

Two new signs were erected at the beach carpark and have been dedicated to Huck.








#### **SAFETY / SECURITY**

#### Newsletter Article

Llandudno has not seen any significant crime for the third year in a row. Our neighbors in Hout Bay and Camps Bay have also seen a drop in crime. Coordinated crime fighting has enhanced, and many of our initiatives were carried-over. Zero crime is no longer a pipedream and the effect on property values and general peace-of-mind have been profound.

No budget increases for security are planned for this year, except for the routine minimal inflation increase previously approved at last year's The 5-year budget plan has thus-far enabled us to keep up with the maintenance and upgrades of our 60+ camera system via Rubics; as well as funding the 24/7 public space response vehicle from PPA and off-site monitoring services of OmniVision. This includes the recent upgrade of our UPS systems at all of the camera sites to survive Stage 4 loadshedding, as well as replacement of some critical cameras with new models. Several other software and operational uparades are keeping our system state-of-the-art and an example for other communities that we actively engagewith.

Crime continues a downward trend (see graph) with zero violent crime in 2021 so far. Unfortunately, most crime moved to daytime and there were thefts of 3 unlocked bikes & a skateboard, as well as breaking a camera and the theft of a phone off the beach - chased by the Lifesavers and recovered. However, the number of attempted crimes keeps our responders busy, with several late-niaht suspicious entries via Sandy Bay and many vagrants that walk in the front entrance unhindered. Two incidents have occurred inwhich vagrants attempted to build temporary shelters the immediate surrounding environment.



Reviewing past crime activities in Llandudno, you cannot fail to note the high correlation between crime events and the absence of working alarms / beams. It is very important that all residents maintain their home security system (for example: locked doors, beams, electric-fences, analytic cameras, and panic buttons etc.), and have a Home-Alarm-Response Contract so that in-case of an incident the responders can be invited into your property to assist. Otherwise, the responders cannot enter, and your alarm activations will neither be monitored nor responded to.

As voted on last year, the LCA quickly met the minimum threshold of 100 PPA Home-Alarm-Response subscribers to get the dedicated additional 2<sup>nd</sup> vehicle 24/7. The LCA continues their campaign to get more residents to signup with PPA to meet the minimum subscriber thresholds for PPA to take over manning of the Sandy Bay and Entrance Huts. At the time of publication, the LCA reported that they have 129 subscribers to PPA, and we need to get to 130 for them to man the Sandy Bay Hut and 180 for them to man the Entrance Hut. 
The LSRA continues their policy of only budgeting to fund the perimeter cameras and rely on donated cameras for the internal street views. We have received several donations and pledges for continued expansion and upgrade. The LSRA only accepts camera onto the network that provide views giving broad coverage to the surrounding areas; the contribution from these donors to help fight crime in our community is greatly appreciated and in-keeping with the practice long established by prior donors over the many years.

The LSRA continues to work closely with the HBNW and Watchcon/CCP to coordinate our crime fighting efforts. A large private donation was used to further upgrade our UHF Radio System to provide Llandudno with our own private Channel on the Watchcon network now shared with the Lifesavers. As we have learned over the years, the trick to catching criminals is the speed of the collective response, and this is greatly enhanced by the radio network (which also provides a back-up when cell coverage is down). The LSRA has been actively working with the City and LCA to try and find a solution to the traffic & illegal parking problems at the main beach. The City has been responsive, but a sustainable & reliable solution is still under active discussion. In the interim. community volunteers regulating and supporting our semi-permanent car-guards via the program set-up by CCP - to try and mitigate the chaos that often happens. Similarly, the LSRA has been continuously engaging with the Authorities and LCA on the criminal element being attracted to Llandudno via short-term rentals by irresponsible landlords.

The LSRA Security Committee has worked exhaustively with the Board to increase the number of members in the LSRA so that

#### **INFRASTRUCTURE**

Llandudno has experienced a plethora of infrastructural problems and breakdowns in recent times - ranging from sewerage leaks, intermittent power failures in the lower parts of Llandudno and a series of water outages which culminated in the water supply to the area being cut off for more than eight days during November 2021. The SRA has formed a subcommittee to represent the community with the City of Cape Town on these issues. The subcommittee is also in the process of liaising with the City to put in place a preventative maintenance plan at sewerage leak "hotspots" in the area.

In general, the City of Cape Town responds quickly to reports of burst water pipes, electricity faults and sewerage spills (there has been some exceptions). In the case of the recent major water supply problem, members of the subcommittee have been in contact with Councillor Quintas who is setting up an open day with various City officials to review the problem and determine that such an event is never repeated. The provisional date of the meeting is 8 December 2021.

The sub-committee has also negotiated with the City Traffic Department that a more proactive traffic enforcement service will be put in place during this summer season.

#### **ENVIRONMENT**

And so it is – the baton has been passed over and the "environment" requirements of Llandudno are now in my hands. Many thanks to Huck once again for his great care of our beautiful Llandudno over these past few years. He forged many close working relationships with City of Cape Town service providers – his motto being that it is much better to make friends with the city officials and to politely ask, rather than demand services - an approach with which this portfolio will continue. We will all miss you Huck.

Our in-house vegetation and odd-job team, run by the ever-willing Ashley Weaver, continues to do a fantastic job tidying up our environment. You may have noticed, drainage channels cleared of grass and weeds, trimming back of vegetation protruding onto roads, cutting back of the paths along the open spaces and those near the beach, fixing the stairs onto the beach, grass cutting in open spaces and a number of other smaller jobs. With the wet winter there has been prolific vegetation growth so there is a lot more to cut and trim than usual. Please bear with us – within a few weeks identified key areas will be dealt with. Please let us know if there are any areas that we have missed.

Walking around Llandudno, many of you will have seen that most residents take a lot of care looking after the verges outside our homes. For those that do seem to neglect this aspect, please can we appeal for you to take a little effort in pulling out weeds and trimming back plants and trees. Our service provider has to focus on the public areas.

Many of you will have seen the additional pile of sunbeds next to the central beach path and at the shower area. It would appear that another service provider has won tender for this summer. We are currently following up with the City (thanks Wes Corbett) regarding the pile of sunbeds that are stored from previous seasons – apparently from past vendors that no longer

have contracts. The plan is to try and get these removed. There has already been one bash at removing some of the broken equipment that has landed up in the bushes behind the beach – but still a fair amount to clear up.

Regarding the firebreaks along our southern and northern boundaries – SANParks cleared these areas during the middle of November. Those living and walking on the boundaries should see the cut areas. Kersner Estate has also committed to clearing the firebreak on their property just after the start of the Sandy Bay path.

We have all been affected by the number of builds that are taking place. Welcome to the new owners. There is a lot of frustration from many neighbours regarding rubbish, blocking of stormwater drains, etc. Can the new owners please ask their builders to pick up their litter and rubbish that daily spill onto public roads. One day you will be living here and will be as frustrated as some of your neighbours currently are.
